## **TESTING PROCEDURES:**

We do not send test orders, we actually put you in parallel production, which means you will get the next order the buyer creates as an EDI and a faxed copy. We probably will not notice when an order goes out, as we send over 1,500 PO's in a day. We do monitor whether we get 997's, so if we do not receive one within 24-48 hours, we will be calling you. We use the same procedure for testing invoices. If you could return the first PO we send you, back as an invoice, it would speed up the process. During the testing phase continue to send the paper copies of the invoices, as this is what we use for payment purposes. When we are ready to go production, we will notify you to stop the paper. We will then follow up with a form letter stating that as of the date agreed upon, C&S will no longer pay from paper invoices, but from the EDI document only.
