NOTE:

When CCS makes a change to the detail level expected delivery date on an item as well as changing some other detail; price or quantity for example, we send only one POC segment. This POC segment describes the price or quantity change and is followed by a DTM segment to indicate that the date has been changed as well. The detail level DTM was designed for this purpose and allows us to send the data to our trading partners in the most efficient manner. If only the detail level date has changed, we will send a POC segment using 'CT' to indicate a change of date.

CHANGES:

1. Add Item Transaction

CCS now sends a DTM segment (containing the expected delivery date for the new item) for every "Add" item transaction. We did this for a trading partner who does not keep the original P.O. date at the header level for reference.

2. Delete Item Transaction

We have changed our map to send the existing order quantity and change quantity when we delete an item. We had been sending 0's for both values and several trading partners indicated that they needed to know how many units we wished to delete.

3. Year 2000 Compliance

For Y2k compliance, all dates have been changed to eight digit character dates, i.e. from 981007 to 199801007.

4. Version 4010 Compliance

To comply with version 4010 standards the code "CD" will be replaced with "CT" in the POC segment to represent change of date.

These CCS map changes will not require any changes for trading partners already in a successful parallel or production with CCS, but the information is now available if you wish to use it.
