Documents Required for Canada Customs

All goods shipped into Canada from the United States require the following documents:

<u>Canada Customs Invoice</u> – CCI <u>Appendix A.</u>

 The CCI will include the incoterms specific to the shipment. Incoterms are recognized standards of trade and transportation used in international trade. DDU – Delivered Duty Unpaid – is an incoterm.

Note: Suppliers must indicate on the CCI the Terms of Sale as- *Freight Prepaid* – Column 8, DDU Destination - Column 9.

The CCI must include all the ASN numbers and the new Canadian government regulation to have the 10-digit Harmonized System (HS) code displayed for each line item, see the letter in Business News > Business Alerts..

- <u>Commercial Invoices</u> The Commercial Invoice I must include all the ASN numbers and the new Canadian government regulation to have the 10-digit Harmonized System (HS) code displayed for each line item, see box #18 on the CCI.
- Straight / Master Bill of Lading Appendix B.
- <u>NAFTA certificate</u>, <u>Appendix C</u>, for qualifying goods must be mailed to Sears Canada and must accompany
 the goods if a blanket NAFTA certificate is not used.


